CASAssure provides an internal monitoring system to give assurance to senior managers and the Board that alerts are being responded to in a timely manner, and that ensuing actions are being tracked.

The system allows for storage of evidence and keeps the alerts all in one place, it can be made accessible by all managers across the Trust, and gives access to all alerts if desired.

CASAssure can be used centrally by the Trust's CAS lead, or for the system to automatically distribute alerts to various clinical leads across the Trust, allowing them to respond to the alert via a simple update screen.

Visually engaging reports and dashboards are available to show the progress against the alert's actions, and these can be automatically emailed to key stakeholders on a pre-set schedule - this is another

time saver and ensures that real time information is regularly communicated. These dashboards and reports make it easy to see at a glance which alerts are still open and therefore need to be followed up with the owner.
